### TERMS:

Cash price of \$ to be paid in full before delivery of the dog, and the following breeding reservations:

Sold on full registration, will be OFA hip and CERF certified before breeding and will only be bred to same.

OR

Sold on limited registration, will be spayed/neutered and NOT used for show or breeding.

### CONDITIONS:

Dog must have, and be kept in, a secure area when outside. Provision must be made for protection against the elements, with fresh water available at all times.

Routine care must include rabies vaccination as required by the state of residence and other vaccination boosters as recommended by your veterinarian. Dog is to be maintained in good condition, neither under nor over weight. It is a medically accepted fact that an overweight condition creates a predisposition toward hip Dysplasia. An obese condition will void guarantees on this dog. Dog is to be kept parasite free with routine stool checks and treatment as recommended by a veterinarian.

For this guarantee to apply, the dog must be x-rayed for hip Dysplasia clearance before 30 months of age by a licensed veterinarian and film submitted to OFA. If a repeat study is requested, the time limit suggested must be met. If found to be dysplastic, and

providing a) the dog is euthanized; b) or if it is kept as a pet, it is sterilized and therefore removed from the gene population, the buyer may choose to accept, at the breeder's discretion, either a replacement dog OR a refund of \$ upon receipt of the following: buyer agrees to supply the breeder with a copy of the x-rays and report of dysplastic reading, plus veterinarian statement indicating animal has been sterilized or euthanized if not returned to the breeder. However, euthanization is NOT to occur prior to breeder's knowledge of the dog's condition. Replacement or refund policy is applicable only if the dog is with the original owner and the dog must not have been used for breeding. PRA – both parents are non-carriers of the gene that causes the prcd form of PRA, so all pups in this litter will not be affected with the prcd form of PRA.

Grizzlypeake must be at the beginning if the registered name of this dog for any guarantee to apply.

Careful and thoughtful consideration has preceded both the sale and purchase of this animal. It is the mutual understanding of both the buyer and family. However, if UNUSUAL and DIRE circumstances require that this animal can no longer remain in the possession of the buyer, it is agreed that the animal, including AKC registration papers, be returned to the breeder, at the buyer's expense. **Buyer agrees that this dog shall not be transferred, sold, or given to another party without previous notification of the breeder, and the breeder shall have first right of refusal.**

Buyer agrees that this animal shall not be used in a breeding program to supply either directly, or to an agent thereof, who sells outright or consigns to a pet shop, kennel, or individual whose purpose is mass production, wholesaling, or retailing of purebred dogs.

Finally, buyer agrees to take this dog to his veterinarian for a health check up within 72 hours of taking possession of this dog. Breeder's responsibility for communicable disease of this dog is void if not reported within this 72 hour period.
